

## ORGANIZATIONAL AND OPERATIONAL RULES AND REGULATIONS OF THE UNIVERSITY OF DUNAÚJVÁROS VOLUME III

## STUDENT REQUIREMENTS FRAMEWORK

Dunaújváros 2024.

In force from February 15th, 2024

Based on the provisions of the Law CCIV of 2011 on National Higher Education (hereinafter: Nftv.), the Government Decree N° 87/2015. (IV.9.) on the implementation of certain provisions of the Law CCIV of 2011 on National Higher Education, the Government Decree N° 423/2012. (XII. 29.) on admission procedures in higher education, the Government Decree N° 137/2008. (V. 16.) on the state-recognized language examination certifying foreign language proficiency and on the homologation in Hungary of the language examination certificates issued abroad certifying foreign language proficiency, the Government Decree N° 51/2007 (III.26.) on the benefit allowances of students participating in higher education and the individual fees they must pay, the training and output requirements referred to in § 16/A of the Nftv, as well as, the provisions of the Ministry of Human Resources Decree N° 8/2013. (I. 30.) on the common requirements of professor preparation and the training and outcome requirements of individual courses, the University of Dunaújváros, as part of the Organizational and Operational Rules and Regulations of the University of Dunaújváros, defines the Student Requirements Framework as follows:

## Introductory and implementing provisions

- (1) The scope of the Student Requirements Framework (hereinafter referred to as the "Regulations") shall apply to the University of Dunaújváros (hereinafter referred to as University), to the studies and examinations of students, visiting students, participants in adult education or other training enrolled in bachelor's and master's degree programs, tertiary vocational and postgraduate specialization programs, part-time training, and to the administration related to final examinations for those who apply for final examinations after termination of their student status, as well as to all teachers, researchers, and employees of the institution who act in and contribute to these matters.
- (2) The Admission Requirements in Chapter 1 of the Rules and Regulations shall also apply to persons who have applied for admission to training at the University.
- (3) The Student Requirements System shall specify, based on the provisions of the Nftv, in particular:
  - a) the admission procedure (Chapter 1),
  - b) the procedure for exercising student rights and fulfilling student obligations, the procedure for processing applications and appeals related to student status, the procedure for legal remedies, the procedure for studies, and the procedure for the acquisition and control of knowledge, skills, and abilities, the studies and examination procedures (Chapter 2),
  - c) the rules on the establishment and fulfillment of the student's payment obligations, the rules on the distribution of student benefit allowances, and the rules on student fees, charges, and benefit allowances (Chapter 3),
  - d) the rules on student disciplinary and compensation proceedings (Chapter 4).
- (4) These Rules and Regulations are part of the Organizational and Operational Rules and Regulations of the University of Dunaújváros.

- (5) The present Rules and Regulations were adopted by the Foundation for the University of Dunaújváros as the Maintainer by its Board of Trustees' Decision N°. 6/2022 (II.08.) and amended by the Decisions of the Board of Trustees N°. 3/2022. (VI.28.), 1/2022. (IX.26.), 4/2022. (IX.26.), 5/2023. (III.09.), 2/2023. (VI.28.), 12/2023. (VIII. 30.), as well as, 10/2024. (II. 06.).
- (6) The amendment to the Rules and Regulations adopted by Resolution N°. 10/2024 (II.06.) shall enter into force on 15 February 2024, at the same time, the previous relevant rules shall be repealed.
- (7) The University shall ensure the publication of these Rules and Regulations in the usual local manner and shall publish them on its website.
